# BUILDINGS WORK PACKAGE - PAGER POWER'S EXPERTISE AND SERVICES

#### **Overview**

Developing a new building project requires consideration of many different aspects of the planning system. To make things easier, Pager Power has put together this document with the target audience of building developers in mind. The aim of this document is to highlight the importance of considering the potential issues surrounding aviation, communications and glint and glare for building developments. It is important to ensure that these areas are considered early in the project timeline so that unexpected costs and delays are prevented as much as possible.

Note that this guide has been developed with tall buildings in mind (typically measuring five storeys or more). However, depending on its locations, a smaller building may sometimes face similar issues during planning.

#### How can Pager Power assist building developers during the planning process?

The three key areas that Pager Power typically assist building developers in are:

- Aviation
- Communications and Television
- Glint and Glare

Assistance may be required in the form of technical impact assessments, reviews of technical objections or consultation and meeting attendance to provide expert support where needed.

Each of these areas can be assessed through a variety of consultation, modelling and desk-based research. The key issues that a developer may come across are discussed briefly in turn on the following page.





#### **Aviation**

• Tall buildings offer two key risks to aviation. The building may be deemed a physical obstruction to aircraft as well as interfere with aviation radio waves from infrastructure such as radar and other aviation navigation aids. Impact may depend on proximity or visibility to infrastructure. Aviation lighting may be required and the use of cranes will likely need to be considered. If the proposed building is within a Public Safety Zone (PSZ), then restriction on the development type may apply.

#### Communications and Television

• Tall buildings act as an obstruction to wireless communications systems. This can cause interference to or a complete loss of signal at the receiving aerial. It is best practice to investigate the potential impact on wireless signals, though it may not be requested by a planning authority. The infrastructure that could be affected includes wireless point-to-point links, terrestrial or satellite television, radio and mobile phone signals.

#### **Glint and Glare**

•Glint and glare is the effect of solar reflections upon surrounding receptors caused by façades which can produce specular reflections. The most common material assessed is glass and key receptors include roads, dwellings and aviation (ATC Tower and approaching aircraft). Effects range from impacts upon amenity as well as safety. The requirement for an assessment may vary between planning authorities but a number of high-profile cases have made assessment requests more common.





#### What are the techical issues?

A deeper dive into the specific issues and receptors for each of the three areas of Pager Power's expertise is presented below:

- Broadband connectivity

#### **Glint and Glare**

- Aviation ATC Tower, approaching aircraft, and circling aircraft
- Solar intensity calculations
- Railway signals, crossings and train drivers
- Safety of road users typically main roads (motorways, A and B roads)
- Ammenity of residents (Dwellings)
